- That Council notes the completed actions, and ongoing actions taken by Bayside Council, Georges Riverkeeper, Georges River Council and Sutherland Shire Council that contribute to protection of migratory and shorebirds.
- That Council notes that Bayside Council, Georges Riverkeeper, Georges River Council and Sutherland Shire Council will advocate to the State and Federal Government for protection of migratory and shorebirds when opportunities arise.

That Council considers the following points as part of the development of the Biodiversity Strategy:

- a A review of how it is responsible to provide protection of Shorebirds under the EPBC Act as landholders.
- An overarching Conservation Plan specific to the Local Government Area for how it will address the conservation of shorebirds, leveraging the Wildlife Conservation Plan for Migratory Shorebirds, including reviewing, 8.3 Anthropogenic Disturbance, and specifically noting recreational activities such as fishing, off-road driving on beaches, unleashed dogs and jet-skiing as being problems.
- c An investigation of a Wildlife Protection Area Category 1 (WPA1) being declared at Landing Lights, Sandringham Foreshore and Dolls Point beach that bans dogs on and off-leash to provide greater protection to the shorebirds.
- d An investigation as to whether the Bayside LEP could have a similar clause to the Georges River Council Clause 6.6 Foreshore Scenic Protection Area Objective 1(e) to encourage the recovery of threatened species and their communities, populations and habitats. In this regard, there is nothing in the Bayside LEP regarding recovery of threatened species. Whereas Georges River Council DCP has a much stronger requirement stating development cannot take place if it will have any adverse damage to existing marine environment, etc. The Bayside LEP requires Council to notify if it is likely to have an impact.

## 10.16 Request for Tender (RfT) F22/108: Bayside & Georges River – Contract for Collection and Associated Waste Management Services

**RESOLUTION**

- 1 That the attachment to this report be withheld from the press and public as it is confidential for the following reason:
  - With reference to Section 10(A) (2) (d)(i) of the Local Government Act 1993, the attachment relates to commercial information of a confidential nature that would, if disclosed, prejudice the commercial position of the person who supplied it. It is considered that if the matter were discussed in an open Council Meeting it would, on balance, be contrary to the public interest due to the issue it deals with.
- That Council note the resolution to decline all Tenders in accordance with Regulation 178 (1)(b) of the Local Government (General) Regulations 2021, at its meeting of 27 September 2023, and delegate authority to the General Manager to enter into negotiations with any person (whether or not the person was a tenderer) with a view to entering into a contract in relation to the subject matter of the tender.
- That Council, following clarifications, negotiations and evaluations, enter into a Contract with the preferred tenderer, Veolia Environmental Services, under delegation to the General Manager for their highest scored 'Alternate 12 + 1 + 1 + 1 year' submission, to an estimated value of \$11,875,657 in Contract Year One for the base Services if executed by both Bayside Council and Georges River Council (excluding GST), or an estimated value of \$12,932,043 for the base Services if executed by Bayside Council solely.
- That Council note that the estimated values stated above may change throughout the Contract Term based on the required Service provisions, that can increase (i.e., domestic and/or commercial growth) or decrease (i.e., customers opting to temporarily suspend Services or utilise third party collection providers).
- That Council note that the Contract excludes options Pre and Post FOGO for the Contractor to provide Community Education, and instead includes the selection for Council to undertake this service Pre and Post FOGO. The Community Education for this contract is estimated to be \$460,000 in Contract Year 1 based on Councils current Property data.

That Council note that the cost of approximately 28,000 Mobile Bins for Organics Services be paid upfront by Council to the preferred Contractor to be funded with the assistance of a \$1.255M NSW EPA grant, which is reflected in the Tendered reduced Service Rates (includes repairing and/or replacing the bins).

7 That Council provides the General Manger with the delegated authority to sign all associated documents on behalf of Council.
