That Council acknowledges the efforts of our staff and other emergency services in responding to the extreme weather event in the early hours of Friday 4 April 2025.

Mayoral Minute

In the early hours of Friday 4 April 2025 our coastline, along with others to the North and South of the Bay, experienced an unprecedented storm event. High winds and heavy rain combined with a king tide meant that our coastline and private property at Dolls Point were battered and covered in metres of sand.

The damage bill is in the hundreds of thousands of dollars and I want to commend our staff for their tireless work, starting at 3am on Friday morning and continuing throughout the following days.

Thousands of tonnes of sand had to be moved along the foreshore parkland, homes made safe, broken safety rails and concrete pathways repaired.

Our residents have expressed their gratitude for the work staff did to clear driveways and shovel sand from front yards. In this time of crisis our team met the challenge. Within a matter of hours the roads were cleared and within days Pine Park and the foreshore were back to looking well cared for.

Our response to these challenging events is to be commended.
